1. The 27<sup>th</sup> Annual General Meeting of the Company to be held on Saturday, the 31 December 2022 at 11:30am at Digital Platform.
2. Record date is 08 December 2022.
3. The board recommended 2% (Two percent) cash dividend to be distributed to all the Shareholders other than Sponsors/Directors. The Sponsors and Directors hold 4,08,76,546 shares out of total 13,62,69,093 ordinary shares. The cash dividend to be payable to the shareholders Tk. 1,90,78,509 for their holding 9,53,92,547 ordinary shares.
